## Function of Office Bearers

## 1. President -

- a)To take chair and conduct proceedings of the meetings of the Executive Committee and General Body
- b) To execute casting vote as and when required
- c) To do all other acts as may be delegated by the Executive Committee from time to time
- d)To call meetings of the organization

## 2. Vice President -I

- **a)**shall look after the General affairs of the organization of northern states of India and in absence of **President** shall perform all the duties andresponsibilities on his or her behalf.
- b)The Vice President shall make sure that State and District Committees are constituted and meetings are being conducted on time
- C) Will generate new membership of NASVI

## Vice President - $\Pi$

- a) shall look after the General affairs of the organization of southern states of India and in absence of President / Viceshall perform all the duties and responsibilities on his behalf.
- **b)** The Vice President shall make sure that state and district committee are constituted and meetings are being conducted in the southern states
- C) Will generate new membership of NASVI

## 3. Secretary -I

- a)Shall be responsible to look after the functioning of State Committee / State Executive Committee of northern states of India.
- b)To make better coordination between the State and Central Committee.
- c)To present the reports of the progress and meetings of the state Committees
- d) Will take necessary steps to ensure that that MIS of membership is updated and membership is paid
- e) Will be responsible for implementation of Act/Rules in the concerned states and organize trainings on TVC
- f) Will push for implementation of social security

Secretary -∏-----

- a)Shall be responsible to look after the functioning of State Committee / State Executive Committee of northern states of India.
- b)To make better coordination between the State and Central Committee.

- 4 Treasurer
- a) The treasurer shall supervise over the financial affairs of the organization
- b) To get audited the income and expenditure of the organization
- c) The account of the organization in the bank will be operated jointly by treasurer and any office bearer including the co-ordinator as may be decided by the Executive Committee
- 5. Coordinator-The co-ordinator shall be designated as National Co-ordinator
- (a). To be in charge and shall be responsible for the management of the organization.
- (b). To keep the records and documents of the organization, to prepare the various reports including annual reports and report to the donor
- (c). To represent grievances of members to the Govt. and carry out all the correspondence with the Govt., Other organizations and within the organization.
- (d). To carry out all the decisions and instructions of the Executive committee.
- e) To sign all documents and legal papers necessary for filing cases in the court on behalf of the organization
- (f). To convene the Meetings of the Office bearers / Executive Committee M/ General Body etc in consultation with the President.

4. NASVI committee –Guidance Committee could also be the NASVI Executive committee and can be considered as the main committee or Director Body

In this street vendors from lowest level will be involved.

Since election will be held representative in touch with street vendors. Street Vendors will also have the right to recall representative. Every body will have definite program, direction of work will be fix and organization will be strong. Committee position should be as follows:
