Report of the Co-ordinator

24-06-2019, Rajiv Nagar, Patna

Last time we met was in September 2018 during the Annual General Meeting. This meeting got delayed due to the General Elections in the country. Our hopes have arisen due to election of a strong Govt. Recently; Govt has announced economic survey of street vendors of India. Though we do not know the consequence of this, yet we welcome this move.

In our last General Body meeting, the Union Minister for Urban Affairs, Shri Hardip Singh Puri had assured that very soon he will call a meeting to monitor the progress of the Street Vendors. On 8th February, a National Level Meeting was convened by Govt of India in Vigyan Bhawan in which NASVI was given lot of importance and the issues of Street Vendors were discussed threadbare among all leading concerned Govt officials from India

On 25th February and 6th June, a guideline has also been sent and the responsibility of monitoring the implementation has also been given to Support Urban Street Vendors (SUSV) unit of NULM

The Ministry of Urban Affairs has also constituted a Committee to visit 60 cities of 26 states to study and report on the implementation of Street Vending Act on the ground.


NASVI organized the 10th Street Food Festival with FSSAI - A major impact of this was the Ministry of Urban Affairs took a decision to organize Shahar Samridhi Utsav which was organised in many states and NASVI actively participated in Bihar and Delhi.

Healthy India Yatra and Eat Right Mela: The Food vendors got opportunity to participate and share their thoughts during the Healthy India Yatra and Eat Right Mela organized by FSSAI.

Street Vendors Day is becoming popular year after year. Delhi Govt finally made the scheme while after long long delay rules have been framed by Govt of West Bengal.

After the bitterness created by Street Net and as discussed in the last EC meeting, three organizations SIVARA, NASVI and UPTA have come together and registered Self Workers Global in Madrid. SWG was launched in Geneva last week.





Ranking of the States

Centre of Civil Society (CCS) did a ranking of states based on indicators like notification of rules and schemes, survey of street vendors, constitution of TVCs, issue of identity cards, preparation of city vending plan, constitution of TVC, creation of vending zones etc. Unfortunately, the realities of the ground are not taken care and NASVI rejected the study in the February 8 meeting where it was released even though for strong reasons it is put on the website of the Ministry.

States Progress:

❖ Delhi

After lot of efforts and persuasion ,the Delhi Govt adopted the scheme on 15th April .Last year elections to 27 TVCs were held .However 147 vacancies were still to be filled for which notification has been issued to hold elections on the 30th June . Last year the elected TVC were given zone wise training.

We also thwarted effort to evict some markets by the Police and the Municipal Corporation. These are Laxmi Nagar, Mndawali Pulia Sabzi Mandi, Shastri Park, Zama Masjid, Badarpur Sabzi Mandi, Karol Bagh Market, Janata Colony, New Usmanpur ghora weekly market, Bhikhaji Cama place.

NASVI also identified some markets and made the vendors aware about the Street Vending Act and organized them into market committee- Janata Colony Welcome ,Rehri Patri Ekta Manch , Footpath Vikreta Ekta Manch Purani SeemaPuri , Ghonda Sapthahik Bazaar Ekta Manch ,Footpath Vikreta Ekta Manch Rahman Chowk Khajuri , Rehri Patri association ,Shalimar Bagh Burari ,Nathupura Footpath Vikreta Sangathan .

NASVI also wrote letters to LG, Police Commissioner, Municipal Corporation Commissioner and also took delegation to the 12 Deputy Commissioners who head the TVCs

TVC members training cum strategic planning meeting: WEIGO supported NASVI to organize training of TVC. The last training was converted into a strategic planning meeting. A major decision was to build pressure on the Deputy Commissioners who now head the TVCs

The decisions were as follows


- a) All Political parties and their leaders to be informed that if they do not give importance to the street vendors, they shall be boycotted.
- b) Deputy Commissioners to be pressurized to convene meetings of TVCs
- c) Get vendors issue in the manifesto of Political Parties
- d) Create pressure on Delhi Govt to constitute Grievance Redressal Committee
- e) Write letter to Delhi Govt to adopt the scheme
- f) Write letter to Police Commissioner asking to give receipts in case of confiscation
- g) Vendors write to DCs for regulation.




❖ Uttar Pradesh:

The Allahabad High Court ordered for implementation of the rules and schemes. The Principle Secretary on 15/6/2017 wrote letters to Municipal Bodies for implementation. 4171 certificates have been issued by 17 Municipal Corporation.

There are serious issues in **Hapur** and the vendors had to go to court. In **Agra** 4000 vendors applied for ID cards of which on 400 vendors got id card on 3-04-2019. In **Lucknow** the High Court intervened and all vendors were asked to apply by 10 June. The Municipal Corporation distributed 15122 forms of which only 12311 persons applied .Now these will be verified. Many non vendors have filled the forms. Shri Gokul Prasad registered protest against this The Lucknow Municipal Corporation has identified 200 Vending Zones of which the traffic police has objections over 20 of them .The Smart City Agency has identified 168 vending zones.

- A list of possible vending zones submitted to Municipal Corporations.



14 cities including Lucknow, Meerut, Ghaziabad, Varanashi, Agra, Allahabad, Moradabad, Gorakhpur, Aligarh, and Muzaffarnagar have identified 1.96 vendors for issue of identity card. NASVI had also applied in tender advertised by SUDA but we got rejected due to technical reasons.

❖ Madhya Pradesh

Madhya Pradesh has framed rules and scheme. TVCs have been constituted. 12000 vendors have been surveyed in Gwalior but identity cards have not ben issued. 7 Vending zones have been created .Some vendors have occupied space in 5 vending zones but 2 vending zones are empty. Pintu Park has 450 vendors, Chowpatti has 36 vendors, Phulbagh has 34, Birla Nagar has 150, Kampu has 18 and another 244 .There is also a Women Vending Zone near Hanuman Talkies but nobody is there.

Bhopal: TVC has been constituted on the basis of nomination but there will be election to the TVC after General Election. There are fifty two districts in the state and around 7-8 Divisions. Each Division has five districts. Grievance Redressal Committee has been constituted of which Shri Gopal Singh Lodhi and Ratnesh Upadhyay has been made members.

Bhopal: TVC formation has been done through nominations. There are rules and schemes in which merging 5 towns it has been divided in small parts. In one part Bhopal Municipal Corporation, Shihor Municipal Corporation, Vidisha Municipal Corporation. Grievance Redressal Committee for the vendors was formed in Raigarh whose members are Gopal Singh Lodhi and Ratnish Upadhaya.

Jabalpur- In Jabalpur part Bhilwada, Jabalpur, Mandla, Bigbora, Sehda, Balaghat, Shivani, Narsinghpur Street Vendors' Grievance redressal committee was formed. In total 52 districts in which 7-8 such committees will be formed.

❖ Jharkhand

The State Govt framed rules in 2015 but some street vendor organisations demanded amendment and the State Govt adopted the amended Rules in September 2016. Scheme was passed after a year in 2017. Three agencies were selected for facilitation of the implementation – Saman Foundation, NF Infratech Pvt Ltd and Haryana Nav Yuvak Kala Sangam were selected in Jharkhand.

TVCs were constituted in all the 44 important ULBs in proper way though meetings were not conducted in proper manner. Survey has been completed in all these places through an APP based mapping. 17,000 vendors out of the 37,701 vendors surveyed have been given identity cards. NULM officials say that they will be covered in the second phase. Vending Zones have also been identified.

A Vending Zone has been created in Ranchi in which 427 vendors have been allotted space. In rest of the cities, land has been identified for vending zones.

In Madhupur and Deoghar, meeting with Municipal Bodies have been held and street vendor organizations are being identified in these two places

NASVI has also intervened in Dhanbad

Vending Identity Card have been distributed in Telco Market and necessary documents collected from vendors.



❖ Bihar

The State Govt notified rules and scheme is February 2017. Bihar has 142 ULBs and Town Vending Committees (TVC) have been constituted in all the town survey has been conducted in 53 towns. 59501 Vendors have been identified 12870 IDS have been distributed. 346 vending zones have been declared. NASVI prepared city vending plan for Bhagalpur Municipal Corporation. As a result the Department of urban Development asked all ULBs to prepare vending plans.

Municipal Bodies have submitted plan for 27 Vending zones. 15 Vending zones have been declared by the urban Department reactioning a total amount of Rs 6,16,51,600. 3 Vending zones are being created in Patna.

Strengthening the State Level Co-Operative :- The Bihar state Footpath Dukandar Co-Operative Society has been registered under the 1996 Act. The Board meets regularly and adopts many resolutions. The Board has decided to open 7 beanches in – Patna, Bhagalpur, Begusarai, Chapra, Motihari, Madhepura and Seikhpura. We have begun from Patna and Bhagalpur. A bank account has been opend in Patna which is operated by the President and CEO of the Co-Operative. We make the street vendors are about the problems of street vendors. 91 street vendors of patna and 147 street vendors of patna and 147 street vendors of Bhagalpur have shares.



Modern Pushcart :- NASVI has collaborated with a company 'Swastik Art and Creation'. We are getting the company to manufacture need based push cart for vegetables, fruits and food vendors. After many rounds of interaction with the vendors, the company has come out with different models. Two designs have been approved by the vendors and the company is manufacturing them. They push carts have storage, light, modern which, wash basin and water storage, long term and easy to move from one place to another. These vehicles cost between 33,000 to 40,000 which are available on EMI. This will be launched formally soon.

Distribution of ID cards in Rajgir: After 8 years of struggle in the international tourism city of Rajgir, 350 vendors were distributed identity cards.

❖ Telangana

HYDERABAD: In February 2019 last TVC meeting was conducted. 22000 vendors survey was done and 15000 Identity Cards were issued to the vendors .Without any facilities vending zone has been designed.

Kutubullapur: In February 2019 last meeting was conducted.1100 vendor's survey has been carried out and 900 ID cards were issued and vending zone created in Shahpur Bazaar.

Sikandrabad: In January 2019 last meeting was conducted. 800 vendors were surveyed and 800 IDs distributed but no vending zone has been created.

Shadnagar: TVC formation is in ongoing process.400 vendors has been surveyed and 800 permanent ID cards have been given.No vending Zone has been created

Warangal: In year 2018, TVC meeting was conducted. In 2015 2000 street vendors survey was done and in 2016-17 200 vendors were issued ID Cards.Vending zone was made and in 2016 8 vending zones were made but out of it 4 zones were cancelled after the court ruling. In the Smart City plan they have also intended to keep vendors out of the plan.No certificate has been issued to the vendors and no vending plan has been made.

Street Vendors many a times approached the Municipal Corporation and related departments for the implementation of the proposed rules for the attempt has been left unattended and neglected. Any step has not been taken to fix the proposed plan

❖ Tamil Nadu

Tamil Nadu State Government on 2nd November, 2015 proposed rules and plan .In the state out of 125 Municipal Council 12 is corporation in which only 11 corporations have Town Vending Commission formed. After Court's Stay order one corporation in Trichy has not been formed. In the Municipal Corporation no meeting has been conducted on town vending committee. According to our information Rajapalyam, Nellikuppam Municipal Corporation and in Madurai Corporation TVC meeting was conducted once. Survey has been done for the street vendor's. In whole of Tamil Nadu ID cards have been given in 500 markets but most of the vendors are out of the survey and so the survey has been has to be reconducted. No vending zone has been identified but 225 no vending zone and 222 restricted vending zone has been identified .Vending plan to all 136 ULB has been prepared. But Planning and accepting Committee did not approved it.



Because of Smart City Plan eviction problems have been arising and vendors have been facing problems. Majorly Sevapalli in Trichy to Thuvkudi, through the contractor for making the service lane street vendors were evicted on 19/4/19. In this regard DC has been intimated and in Auriyallur and Ariyangmanglam witnessed demonstrations.

2 TVC meetings have already been held in Chennai Corporation. There was talk of conducting the next meeting after the election. It was decided to evict the Chennai T. Nagar Osman Road Market. It is one of the big and famous markets of Chennai city. Affected street vendors can expect a big movement.

All street vendors have identity cards, especially some of the evicted street vendors are members of TVC. No arrangements have been made to correct the error in name, address or photo in the ID card.

❖ Karnataka

The Karnataka State Government has notified the rules on May 13, 2016 and made a plan, but no implementation has been done. The survey process started on 17th September, 2017. TVC has been formed in some cities, but they are only active in Mysore and Mangalore. Until now, no single vending zone has been identified. Demonstrations were also held in front of the Town Hall in Mysore.



Bangalore City: No TVC was formed till now and surveyed 25,000 vendors. In January 2018-2019, 15,000 ID cards and vending certificates were made till now. No vending zones were identified. Plan for distribution of ID card from next month.

Mysore: Last TVC meeting was held in 2018. Survey 1500 vendors and issued 1500 ID cards and identified vending zones but no development till now.

Bellary: No TVC was formed yet. 10000 vendors have been surveyed. And ID cards will still be released after the elections.

Bijapur: TVC was formed but no implementation till now. In 2014 35000 vendors were surveyed and issued 1300 ID cards, in 2018 and issued 500 ID cards. Already 400 vendors were evicted 2 months ago. Complainant to Commissioner and NULM official but no reply.

Gadag: The last TVC meeting was organized in December 2018. 2947 vendors surveyed and 1500 ID cards and wading zones were identified in Bativiri.

Hunsur: 625 temporary ID cards were issued.

All municipal counseling bodies and political bodies are protesting and torturing the vendors. Vendors are required to issue surveys and ID cards with QR codes and certificates of vendors. Request for implementation of the Street Venders Act has been given to the concerned letter CM3, UD Minister, Chief Secretary, Skill Secretary, Kaushal Mandal Office and Municipal Corporation.

❖ Andhra Pradesh

The State government has notified the rules and plans on March 31, 2017 and June 15, 2016 respectively. TVC is set up in three cities of Andhra Pradesh which are Guntur, Srikulam and Visakhapatnam and the last TVC's meeting in February 2019 will be organized. Survey has been completed in all the cities of Andhra Pradesh and the number of total vendors is 66361 out of which 50606 vendors have already been issued ID cards and are now closed due to elections and from next month in Vijayawada, Srikulam will start again, Visakhapatnam, Godavari East and West, Guntur, Nulor, Chittur, Kadapa, Prakram and Krishna. Identity cards have been distributed to the TVC members. Until now, no single vending zones have been identified.



Visakhapatnam, one vending zone was created but due to the absence of a customer, it could not be successful.

MEPMA has a review meeting on the State Level of Street Vending Law.

In Guntur TVC meeting was held in which discussion of issuing ID card was discussed.

In Vijianagaram Vending ID cards have been issued to 160 street vendors.

❖ Kerala

State Government has made the rules and the pscheme .In total out of 93 only in 76 ULBs TVC has been formed .Survey has been done for 93 ULB and 19751 vendors have been included in the survey in which among 5 ULB 1357 vendors in Mallapuram ,Shonoor,Chalkudi ,Thissur and Chaavkakkad IDs were distributed. Not a single vending zone has been identified.

Kerala Government in March, 2018 at Panchayat level street vendor survey has been announced and till date it has not started.

Palghat: Through the Municipal Council in mid of March 2018 in Palghat issued 652 ID Cards. TVC members cards were distributed .TVC members were given ID cards .Last TVC meeting was conducted in 2018 .No vending Zone identified.

Pallakkad: In Municipal Council there are 52 wards and and through it 675 vendors have been surveyed in which 550 vendors ID has been given. In November 2018 TVC has been formed. After the Election results next survey would be done.



Cochin Municipal Corporation: Survey has been done in 74 Wards. There is no progress in TVC formation. In street Vendors survey 1987 Vendors have been identified. 137 vendors were given ID Cards

Trichur Corporation: Street Vendors survey is in progress.

Kannur: In Iritti Municipal Corporation vendors are evicted by the order of High Court.

In Kannur district, National Footpath Underwandi Petikara Thojilali Union State working committee organised a meeting in Kerala. In this meeting vendors took a decision against Kerala Government for taking negative behaviour against the street vendors and they decided to protest for the same. Survey has not been completed and the identity card also not distributed. We have decided to conduct a general Council meeting within three months in Kannur

❖ Rajasthan:

Rules of Rajasthan, Schemes and TVC are maintained but there is on regular meeting of TVC anywhere. In Kota survey of 5443 people had done but no one had identity card.

More than 200 people have been surveyed in **Mount Abu** the work of beautification is being done by the municipality and Brahma Kumari Sansthan of Mount Abu such as Light, Toilets have been constructed.

Vidya Nagar:- After the order of the court 40-50 people have been given a shop to each in Vidya Nagar.

In Pali, So far, three hundred vendors were given the identity card and survey had done of seven hundred people.

Jaipur : Three meetings of the TVC have been conducted . One meeting was boucotted by the vendors representatives because in the minutes of the meeting the Muncipal Corporation only mentioned their issues and not the issues of vendors. A company of Chennai has been commissioned for survey . Only 7321 vendors forms have been filled

Bikaner : On 12th June the meeting of TVC was conducted . 2695 registered vendors problems were put in front of the officials . Officals assured to solve the problems at the earliest . The agency working for the city has proposed 21 vending areas in 4 Zones . All vendors have been assured of quick distribution of vending identity cards and certificates .

JODHPUR : Food vendors in Shastri Nagar circle has witnessed that street vendors are being tortured by the Municipal Corporation and police administration even after the Act 2014, so the street vendors will submit petition to Jodhpur High Court against municipal and police administration.

6234 Vendors have been surveyed, 300 people have got identity card in Pali. An order letter has been issued by the Rajasthan government in which the city bodies have been asked to follow the Path Vendor livelihood Conservation and Business Act 2014, according to the laws of 2014 for eviction and transfer of path sellers.

On March 18, a general public meeting of street vendors was organized in which all street vendors under the Act 2014, under the leadership of Union Convener and NASVI Executive member Om Prakash Dewada, traffic Deputy Superintendent Smt. Nirmala Vishnoi and Traffic Inspector Mr. Rishpaul Shekhawat Road Street vendors to organize the business place as per the Act and keep your business location clean and Shared information. The election of the union was also held in the General Assembly in which Mr. Om Prakash Dewada of the organization was re-elected by all the President with the consent of the election Advocate Mr. A. Kayyum, Shankar Lal Makhe and the presence of street vendors in the presence of Rajendra Vesavanav.

Training of Members of the Town Vending Committee: One day training was organized on 12th October 2018 in Town in Jaipur by members of Town Vending Committee. Approximately 30 members of 7-8 municipalities participated in the training. During the training, the members told that the Town Vending Committee is not heard in Jaipur. Due to the municipal dogma, the vendors are enabling to put-up their issues. There was a debate between the locals and the representatives of the vendors started placing blame on each other.

Jhunjhunu : The Municipal Council under the rules 2016 led by the Executive Office Vinay Pal began to identity and give vendors identity card and also establish them into vending zone so that the city can be free from encroachment . He began the work from certain area of the city and plans to cover the entire city .All the vendors of the city have to be established in the vending zone

❖ PUNJAB

,Rules and Schemes have been framed in Punjab and TVCs have also been constituted . 21622 vendors have been surveyed of which certificates of 900 vendors are ready . But have not been distributed. Vending zone creation process have been going on in many cities of Punjab and the process of vending card distribution has also been readied . However the work progress is very slow . The Chief Minister has provided guidance and instructions to the officials from time to time for quick implementation of the Act but the results are not encouraging . 1500,2000 ,2200 is the rate fixed by Muncipal Corporation in Ludhiana .



In the recent TVC meeting of Ludhiana , a proposal to create 9 vending zone in Zone C has been sent to the Govt . Before this ,there was discussion to create 40 vending zones . A memorandum was also submitted to Urban Development Minister Navjot Singh Sidhu for implementation of the Act .



❖ West Bengal:

After many jildah jahan, West Vanding Rules 2018 has been formed in West Bengal. But there is still no information about implementation. Nasavi's member organization has made the government aware about the situation. It is tragic and thoughtful that even such organizations do not receive the information.

HAWKERS SITUATION AT KOLKATA

Due to hawkers shade, there caused a huge fire hazards in Gariahat, Kolkata wherein it damaged buildings and also about 85 vendor kiosks. The Kolkata Municipal Corporation (KMC) have arbitrarily constructed tin kiosks of same size and is forcing the hawkers/vendors to install it replacing their old stall structures irrespective of being bigger or smaller. Moreover, KMC without discussion and coming out with a viable replacement have directed the hawkers not to use plastic shades which protects them from sun and rain.

That in a similar pattern, the KMC are forcing hawkers of Sealdah, Hatibagan and Burrabazar to make small hawking structure and remove all plastic shades arbitrarily.

That the KMC have not formed Town Vending Committee in accordance to the guidelines of the act and are only discussing all issues with TMC led unions debaring representatives from all other unions like Jai Hind Calcutta Hawkers Union and others unions affiliated with RSP, CITU, AITUC, AICTU, HMS etc.

That we had collectively taken up the matter before the Hon'ble High Court, Kolkata for the formation of Town Vending Committee to which the Hon'ble Court have directed KMC to act as prayed for. But this effort too have gone in vein and we have decided to approach again before the High Court so that we are included and/or KMC constitute Town Vending Committee.

That Jai Hind Calcutta Hawkers Union is acting for years together effectively to the needs of hawkers and we are also planning to get a Railway Hawkers Union registered very soon. A Committee to that effect have already been constituted.

❖ Gujarat:

Among the total number of 28340 Hawking Street Vendors only 1400 ID Cards were given for which the vendors are unhappy and expect much more something concrete.

It was informed by the vendors that the Municipal Corporation charges Rs.2000 from each of the vendor but gives the receipt of only Rs.500 and additionally they ask for the Affidavit in which against the law vending is restricted. Some vendors even went to the Courts against this law.

❖ Uttarakhand

नगर आयुक्त आलोक पांडेय की अध्यक्षता में हुई बैठक में रेहड़ी पटरी हाथ डेली लघु व्यवसायियों के संगठन के प्रदेश अध्यक्ष संजय चोपड़ा आदि भी मौजूद रहे। इसमें चर्चा में सामने आया कि पिछली बार हुई सर्वे में ढाई हजार के करीब स्ट्रीट वेंडर हैं। मगर इसमें से हकीकत में अब कितने वास्तविक हैं इनके पंजीकरण कराने के लिए फिर से तारीख तय करने की बात हुई। जिसमें तय किया गया कि 11 से 30 मार्च तक पंजीकरण चलेगा। इसमें दस रुपये के निर्धारित प्रोफार्मा पर 100 रुपये शुल्क जमा कर स्ट्रीट वेंडर अपना पंजीकरण कराएंगे।

साथ ही यह भी चर्चा हुआ कि नये क्षेत्रों में भी वेंडिंग जोन बनाने के लिए कदम बढ़े। नगर आयुक्त आलोक पांडेय ने बताया बैठक में तय हुए निर्णयों के अनुसार वेंडरों को फिर से पंजीकरण कराना है। इसके बाद आखिरी तस्वीर साफ होने के बाद वेंडिंग जोन बनाकर उसका लाभ दिलाया जाएगा। बैठक में सहायक नगर आयुक्त संजय कुमार, वरिष्ठ 1/1 शिक्षक सुनीता सक्सेना सहित अन्य उपस्थित रहे। (जास)

Schemes and TVC has been formed .In total 2547 vendors survey has been done Rs.150 has been taken per person for the Identity Cards. Municipal Corporation takes Rs. 20 per vendors and Rs. 200 from outside vendors and Rs. 5000 per month.

Although TVC is there in Dehradun but no proper meetings are held. In total 2000 people have been surveyed and 200 vendors are given ID Cards for Vending Zone Ghanta Ghar. 27 Vending zones have been identified and 8-10 vending zones are there.

Dharampur: Rules Schemes and TVC has been formed and since 2 years no meeting has been conducted and 2900 people survey has been done and everybody has been given vending ID Cards.

The creation of TVC on the initiative of NASVI in Mussoorie


In Mussoorie mall road Street Vendors have been evicted which according to Street Vendors Act, 2014 is not legal. Some innocent vendors have been detained when they spoke for the rights of street vendors

Through Nasvi letter was written and various demands were put up to Municipal Corporation, Mussoorie, DC Dehradun, State Governor, and Urban Development Minister Uttarakhand. NASVI is also taking up their issue.

1. Allowing street vendors to vend at their places from where they were evicted
2. According to 2014 Act, survey must be conducted to resettle the vendors

NASVI was written by the Executive Officer (EO) to the Municipal Council, SDM and personally interviewed the formation of TVC and Street Vending Law 2014 and the State Manual. Although the TVC was formed in the past but it was a paper mining supplement. Assuming the plea of Executive Officer (EO) Nasavi, TVC was constituted in accordance with Section 12 (2) of the Rules, 2016, all concerned officers including NASVI were sent and a meeting was organized on 17-06-2019.

The Executive Officer urged Nasvi to assist the municipal council to implement and conduct the survey of TVC and the Uttarakhand urban ferry businessman (livelihood security and ferry business regulation) rules in 2016.



❖ Chhattisgarh

In the state of Chhattisgarh the total number of Nasvi members are 576. TVC has been formed here along with the rules and the scheme. 20 Vending zone has been designed in Raipur. 300 vendors have been provided certificates. Footkar Vyapaar Kalyan Sangh has been expanded till Ballarpur, Bhillai and Raigarh.

❖ Jammu & Kashmir

There are 68 nasvi vendor members. There are no rules or schemes and TVC in Srinagar. Only 2-3 meetings have been conducted with Municipal Corporation by the street Vendors.


Meeting with Municipal Commissioner, Srinagar - Meeting was conducted with the Municipal Commissioner of Srinagar, in which we talked about the issues of street vendors and NASVI's reach in improving livelihood of the vendors. NASVI shared the vision of training the vendors and the meeting ended with good vibes. It was one of the best experiences with Municipal corporation commissioner; we are hopeful that we will be able to do something historic in Srinagar. It is too early to visualize any progress at this stage, but this meeting is a positive indicator that more development will happen in future in matters relating to street vendors.

Successful completion Training of Street Food Vendors in Jammu and Kashmir

Street foods are ready to eat food and beverage, Prepared and sold by vendors, especially in street & similar public places. Street food vendors typically operate from semi- permanent premises & use portable both food carts to sell their items, Apart from providing livelihood opportunities.



Drugs and Food Control Organization, J & K (DFCO) has also come forward and shown support in the commencement of training. The Pre-event preparations done by team NASVI and NESTLE were appreciable. The Jammu and Kashmir vendors were happy to have such training for them, as they felt the sense of belongingness.

❖ Nagaland

An analysis study of 2017 has shown that no work has been done in the implementation of the Street Vending Act 2014 in Nagaland State which means that no rules and plans have been made. They have to constitute a Town Vending Committee. Therefore, no progress has been made till 2019.

❖ Assam

Rules have been made under the main act in Assam. Street vendors (Regulation of livelihood and Regulation of Street Vending) Act, 2016 have been created and passed under the orders of the Governor of Assam. Rules ensure the safety of the rights of street vendors. It was emphasized that Town Vending Committees will be constituted by the State Government for municipal corporation and other municipalities or urban local bodies related to municipalities or town committees at the central and regional level. As of 2019 there are 25 urban local bodies in Assam which are covered under the Vending Act. But in any urban local body in Assam, the schemes have not been prepared.

TVC has been formed in every ULB, but it has been made in haste. Most of the identified ULBs like Kokrajhar, Dhamaji, Diffu, Golaghat and Hailakandi have no information on the information of the vending zone. Town Vending Committees Dull In only 11 ULBs out of 25, only some vendors have been issued identity cards. Vending certificates have not been issued in any ULB nor have any vending plans been made.

❖ Mizoram

On 28th November 2017, in Mizoram, the Governor of Mizoram made arrangements for street vendors of Mizoram (regulation of livelihood and street vending), on 2017 and on November 2, 2017, Mizoram Street Vendors (Regulation of livelihood and Regulation of Street Vending) rules, Passed 2017. TVC has been set up in all 8 ULBs till 2019, June. Work on the formation of the Redressal Committee and Appellate Authority is in the process. There are regular meetings of TVC. The following steps have been taken for street vendors in Mizoram, which have been prepared by Mizoram Government according to the rules and schemes:

- 1) Development of vending scheme and market development scheme for Aizawl urban areas.

- 2) Vending cart distribution for street vendors in Mizoram
- 3) Preparation of Citizen Charter should be issued in a reasonable language.
- 4) Survey for all street vendors in Mizoram

❖ *Maharashtra*

In an encroachment drive in Akola District of Maharashtra street vendors were harassed by forcibly nabbing their handcarts and belongings disrupting their vending but through the intervention of NASVI leader 2014 street vendors act was explained to them according to which it is not legal to evict the vendors and also brought to the notice of the head of Akola Municipality Shri Mishra, which led to allowing street vendors to operate their vending from the places they were being removed.

Honorable Minister congratulated Nassi and FSSAI officials for training street food vendors to maintain cleanliness. They also gave them souvenirs and urged them to conduct similar training sessions in other urban local bodies. NASVI organized a cultural program in collaboration with the Tansen School of Music and Art, more than 50 programs were organized by children and artists.

In the roughly two-minute trailer, we see fiery sautés, noodles pulled and soups ladled, a blowtorch in action, and plenty of enthusiastic customers as various narrators weigh in on the meaning and importance of street food culture. One notes "people have been doing the same dish for 40, 50, 60 years—they never went to culinary school," while another calls it "a chaotic paradise of food."

❖ National Alliance of Social Security (NASS)

The National Alliance of Social Security (Nas) is an informal organization promoted by NASVI in which 5 major Indian organizations are employed to provide social security to unorganized sector workers through a coalition. This forum is currently being coordinated by Net South Asia. At present, on the issue of Labor Code proposed by the Central Government, this alliance makes the main demand of unorganized workers: -

We are identified and registered as laborers.

- Give us maternity benefits of Rs 60,000 (6 months minimum wage).
- Pay us 5,000 rupees per month (50% of the minimum wage).
- Add us with ESI scheme with all the benefits.
- In the event of deformity and death, we pay a minimum compensation of 5, 00,000 rupees.

In order to support the above demand, a nation-wide signature campaign is going on. You are requested to take part in this campaign and send the letter signed by 30th July to Nashville office. A state level workshop is proposed in Delhi and Patna. (Format attached)

❖ Self Workers Global – (SWG)

The exit from Streetnet of certain member organizations, and the negative impulses that come from other affiliated organizations regarding the way of governing in Streetnet, has led NASVI (INDIA), UPTA (SPAIN) and SIVARA (ARGENTINA) to constitute a new organization representing self-employed workers, inside and outside the informal economy.

This new organization, called Self Workers Global, has statutes of professional association, not of NGO. Statutes approved by the Ministry of Internal Affairs of Spain, in accordance with international legislation on professional associations.





The Constitution of NASVI - Membership for trade unions, community based organizations (CBOs), NGOs and professionals like lawyers, teachers, doctors, who work with the issues of street vendors. According to the proposal passed in the Annual General Meeting of last year, each member organization will give an annual contribution of Rs. Non-governmental organizations and individual members will pay 100 rupees annually.

Since 2006, Nasvi was slowly starting the process of reducing the number of NGOs in its membership and promoting MBOs and trade unions in its membership. There is a gradual increase in the growth of NASVI membership. Implementation of national policy was an excitement and in 2004-2005, high membership was reflected. Similarly, after the enactment of the Act in 2014, there has been a lot of increase in membership. The membership of our colleagues across India has increased.

Challenges after 5 years of constitution of Street Vendors LAW

Street vendors are running out of patience: after getting the smart city hypothesis, the National Urban Livelihood Mission Fund, the Act and in some places the court orders, the vendors are unable to understand where their problem is due to difficulty. Their struggle is going on long against powerful anti-forces and they are no longer able to bear it. They want solutions for their livelihood.

Continuous involvement of central and state government: We see this as a major problem because it will not be possible to implement the act without their involvement. They know about issues but avoid joining it beyond a point. Municipal bodies work under the state government and they work only on the instructions of the state government.

Town Vending Meetings: Town Vending Committees Meetings are not organized regularly. Even taking decisions is not taken seriously. Municipal authorities are still making decisions without consultation with the TVC, which is violating the Street Vending Act.

Urban forces are strong against Vendors: Market associations or resident welfare organizations are struggling to use their money to prevent the development of development. Many people go to courts and receive court orders to evict vendors without mentioning the Street Vending Act.

State Government tendering mechanism is faulty: it makes organization's partnership like us very difficult and the agencies which are being taken on the tender often look at the street vendor organization as a hurdle in their work. Many municipal bodies do not allow organizations registered under the Societies Act to participate.

Capacity building of TVC members: More than 2000 TVCs have been set up but their capacity is not being created and thus they are unable to clarify their needs.

To move forward in organizing street food vendors: It is good that we have come to this stage but for organizing at the city level, further improve the work of committees at the state level. Organizing is a good effort but we are prepared for it.

Vendors are still unaware of this act: It is a sad fact that many Street Vendors and their organizations are unaware of this act despite five years of passage of the Act.

Proposed Action Plan 2019-2020

Initiatives from the state government to constitute the grievance redressal mechanism - The Street Vending Act provides a strong grievance redress mechanism that attempts to pre-empt vendors to go to the regular courts. Although four years have passed and they have not been established. Now the time has come for them to be established in the states.

State level committees to play an active role: Until the state level committees play an active role, the Act can not be enacted throughout the country. Therefore, there is a need to accelerate and emphasize their role. Each state committee has to be a whatsapp group and there should be a strong intervention at the state level.

Smart City and Vending Law: The entire violation of the law is being done in the implementation of Smart City Project. How to get rid of this.

District level: A district level committee should also be there, which will give more recognition and strength to the person for the struggle at the district level.

Railway vendor: To highlight the issues of railway vendors and take initiatives to make the government come out without some policies.

Look at PIL: Since many PILs are going to court at the state level, it is very important to keep an eye on them.

Publication of Training Brochures: TVC, Leadership and Organization Development Handbook has been developed and should now be published.

Capacity building: State level training programs are proposed to be organized in the states.

Vendor Day Celebration: Like every year, this year will also be celebrated as Vendor Day on 20th January

Help in the crisis: This should be our most important action now, because in some cities the crisis is increasing.

Identify good lawyers in states and include: More and more organizations resort to courts, it is necessary to identify good lawyers at the state level and help them

Expansion of Street Food Program: This program has the potential to expand in all cities of India. Some progress has already taken place. Training has been conducted in Raipur, Bhopal, Trivandrum, Cochin, Mumbai, Pune, and Delhi. Training has been planned in Bhubaneswar and Srinagar.

Social Security: The Government has pushed the new social security code, it is very important that we work on securing the social security of street vendors and unorganized workers.

Update membership MIS: will be uploaded after deactive members are removed, which we keep taking unnecessarily forward.

Subscription Expansion: The existing organizations will have to work on the principle of bringing new members

Digital Platform: NASVI should emphasize the use of digital platforms for digital literacy and acceptance of payment

Better communication with members: This should be done exclusively through digital platforms.

Connecting with the media at the state level: We need to engage the media more efficiently at the state level.

A film on the status of the Street Vending Act: A film that captures the whole ground of the Street Vending Act and its implementation and difficulties, will be very useful

A Global Body: To promote Self-Vorker Global in the Asia region.
