About India Street Vendor Forum

Street Vending has come a long way from the time the National Association of Street Vendors of India (NASVI) was formed 26 years before on 26th September 1998. Beginning as a network of few organizations, NASVI went on to organize the Street Vendors at the National level giving voice and visibility to a large section of urban poor who were present all across Indian cities but absent in Government Policies and Programs. NASVI went on to organize street vendors across India developing leaders and organizations at the city and state levels.

Responding to the advocacy efforts, Govt of India organized a National Workshop of Street Vending in the year 2000 which led to the setting up of a Task Force and a Drafting Committee and ultimately a National Policy on Urban Street Vendors in 2004. The Policy had mixed responses but the numerous communication between the Govt of India and State Govts in the making and implementation of the Policy sensitised the State Govts and to some extent Municipal Bodies. Implementation led to many experimentations and soon NASVI began demanding for a law which could incorporate the lessons from implementation and experimentations. Some states began enacting law by themselves but finally, after many ups and downs The Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 was enacted by Parliament. The National Urban Livelihood Mission too was launched where implementation of the law became an integral part.

The Food Safety Act was enacted in 2007. Many thought it was a Capitalist gameplan to drive away small food operators like food vendors. NASVI began organizing Street Food Festivals from 2009 and demanding and facilitating the registration of Street Food Vendors. Soon FSSAI began supporting the Street Food Festivals and training the street food vendors developing a training module. Nationwide training of street food vendors started under FOSTAC along with EAT RIGHT MELA. However, as Street Food gained in popularity Big Retail Chains are began grabbing it as their business to the extent that NASVI has launched a campaign #Streetfood by vendors.

COVID and the closure of markets led Govt of India to announce the PMSVANIDHI scheme which came as a big booster to the Street Vending Act. States quickly framed the rules and schemes. Municipal Corporations began issuing Certificates of Vending. Town Vending Committees were constituted. PMSVANIDHI Mahotsava was organised by many Municipal Bodies .The number of PMSVANIDI beneficiaries have crossed 65 lakhs and street vendors

have caught the attention of the Hon'ble Prime Minister and other Ministries. Schemes like SVANIDHI SE SAMRIDHI were launched and the Ministry of Housing and Urban Affairs launched awards to encourage Municipal Bodies. Those availing Rs 50,000 can also graduate to the Mudra Loan which is for Entrepreneurs. Entrepreneurship of Street Vendors are now catching the attention of the Govt

However despite all these the Street Vendors feel they are at a crossroads. What does this cross road mean for the street vendors .This India Street Vendor Forum is all about this . What have been the achievements and what have been the hindrances? How have the Federal and the City Govts responded? How have their own organizations, leaders and vendors have responded? What is the next big thing to happen? How can street vendors take a leap ? What are the challenges?

To be organized on 26th and 27th of September at Constitution Club of India, New Delhi, the India Street Vendors Forum will bring together community leaders of street vendors across the country. The event will begin with participants presenting highlights from their cities followed by the plenary session. The Plenary session shall follow the broad directions of government policies and their impact on the ground Thereafter the event in divided into simultaneous various sessions so that participants go into smaller numbers for more interactive sessions. The sessions are a) 2024 ki Patri ki Kahaani, Vendors ki Zubaani b) Preliminary Session c) Climate Change Impact on Street Vendors' Livelihoods d) Engaging Street Food Vendors in Food Safety and Nutritional Campaigns e) Legal Quiz f) Urban Planning, local Governance & TVC: Challenges and Opportunities for Street Vendors g) Swach Bazaar, Safal Rozgaar h) Entrepreneurial Skills for Street Vendors: Fostering Business Growth and Sustainability with a focus on Women Vendors i) Digital & Financial Literacy and Street Vendors: Bridging the Technological Divide

25 Years of NASVI on 26th September 2023 at NDMC Convention Centre.

On 26th September 2023, NASVI celebrated its 25 years of journey at NDMC Convention Centre, where many respected dignitaries participated and celebrated the magnificent journey of NASVI where Street Vendors of India were represented by NASVI from street to parliament. In the event of the silver Jubilee celebration, many eminent guests were present and motivated the Street Vendors who had come across India for the event.

The Inauguration, lighting of the lamp, and book release “25 Years of NASVI” were done by the dignitaries on the dais i.e., Shri Manoj Joshi, (Sec MoHUA), Sailesh Pathak, (Sec General FICCI), Alay Mohd. Iqbal, (Deputy Mayor, Delhi), Kamesh Sanghi, (Director- livelihoods, American India Foundation), Syed Sultan U Ahmed, (ILO, India), Siddharth Roy, (principal manager SBCD, FSSAI), Chandra Prakash Singh, (President NASVI), Arbind Singh, (National Coordinator, NASVI). 25 Years of National Association of Street Vendors of India of NASVI Shri Manoj Joshi, (Sec MoHUA) Shri Manoj Joshi, (Sec MoHUA) addressed the participants and emphasized how important PM SVANidhi is for the street vendors and the actual implementation of the Street Vendors Act with the coming up of PM SVANidhi. He said that the issue of vending zones should be taken under consideration as the urban population is increasing. he also appreciated the efforts of NASVI in providing opportunities to street vendors of India to raise their concerns and issues on a larger platform.

After the session panel discussion was held on the Role of the PM SVANidhi Scheme in Securing and Promoting the Livelihood of Street Vendors, where Shri Rahul Kapoor, Joint secretary, MOHUA mentioned how the PM-SVANidhi acknowledged street vendors as business owners who contribute significantly to the economy.

Another Panel discussion was held on Street Vending in India- Challenges and Way Forward where street vendors across the country raised their concerns and the way forward for that. The Panel discussion was moderated by Ms. Sangeeta Singh Street Food Program Head, NASVI where it was discussed which are the key areas that need attention and to improve the situation. The celebration ended with a cultural program where the participants for the performances were none other than, street vendors. from performing classical music to modern Hip-Hop dance, the participants outdid themselves and made this celebration more memorable to everyone.



Women TVC Meeting

The Town Vending Committee (TVC) is an important step in citizen participation in their governance. MoHUA's consistent perusal and monitoring has helped constitute around 4600 TVCs across the country. The challenge now is to make them aware of their roles and responsibilities. One-third of all the elected street vendor members in the TVCs are women. A large number of these elected women are getting the opportunity for the first time to participate in any city-level forum. To increase the effectiveness of their participation in decision-making, NASVI launched a campaign across the country. As a prelude to the campaign, NASVI organized a national meeting to discuss the various facets of women's participation in TVCs to make their participation more effective in the future. NASVI invited 100 women TVC members from across the country along with some resource Persons. Their inputs helped design the campaign as well as future capacity-building activities among Women TVC members.

Some of the issues that were discussed in the meeting were How do they see their current TVC member? how is the women's participation in the TVC Meetings? according to them, what are some of the factors that can improve the decision-making of women TVC? How should the women TVC Members be made aware of the Street Vendors Act 2014 and about the schemes of the state?

Many such issues were discussed and raised in the meeting which gave direction to NASVI to work in that area. The meeting was very informative and fruitful in the maximum participation of the women street vendors in the town vending committees.



Policy Dialogue on the Future of Street Vending in Delhi at Ghalib Auditorium



Many important topics were discussed in the meeting about the issues Street Vendors are facing. Among many issues, the issue of women's street vendors was also raised when Ms. Gayatri Sharma highlighted how in India the women workforce is very low. In the wake of increasing tension between the street vendor community and authorities, this number can even deplete to alarmingly low rates, something which has to be given due importance.



Protest on National Action Day

On 9th August 2023, National Action Day was celebrated where the issues faced by TVC were addressed. According to the Street Vendors Act 2014, TVC has the power on many factors but till today the implementation of those powers is being hindered to address this issue, in 70 cities different activities were organized to put forward our demands and rights. In Delhi, the conference was organized whereas in some cities press conference and protest was also arranged. While in Orissa, Bhubneshwar a protest was organised.



Vijayawada Conference

A Policy Dialogue on the future of street vending was organized by NASVI on 27th October 2023, where market leaders from various markets in Vijayawada came and talked about the issues, they are facing while vending. The Meeting provides a chance for the leaders to talk among themselves and also interact with policy makers to find a solution to the challenges they are facing.



Bangalore Meeting

A policy dialogue was organized on 7th November in Bangalore where vendor leaders from various markets in Bangalore came and talked about the issues street vendors are facing and what can be done for solutions. Issues like the eviction of the street vendors by BMC, atrocities by Police officers, and much more. The highlight of the Meeting was that Dr DK Shiv Kumar Hon'ble Deputy Chief Minister of Karnataka who also monitors BMC assured the participants that he would have the meeting with the concerned government officials and that issues would be solved. The dialogue discussion provides an opportunity for the vendor leaders to raise their issues and find a way to them.



NASVI in World Food India

NASVI has been representing Street Vendors of India at every platform, from national to international events and exhibitions. NASVI has been promoting the street vendors. The Ministry of Food Processing Industries has organized the second edition of World Food India held from the 3rd to the 5th of November at Pragati Maidan, New Delhi. The event has the participation of One-thousand buyers and 950 exhibitions from over 81 countries across the globe.

The National Association of Street Vendors of India participated in the Second Edition of World Food India. In the view of 75th celebration of independence, NASVI has organized 15 stalls at the event and brought 75 cuisines which were all prepared by Street Food Vendors. Nasvi has partnered with Food Street which was curated by Master Chef Ranveer Brar. Street food vendors from across the country participated in the event. Empowering street vendors across the country and giving them the golden opportunity to showcase their culinary skills at such international events gave them the entitlement of respect and opportunity.



The 15 stalls included dishes like Pahadi Pakodi, Tamatar Chaat, Nagori Halwa, Milken Anguli Pitha, and many more. Street Food Vendors from Assam, Madhya Pradesh, Tamil Nadu, and more participated in the event. Celebrity Chef Mr. Rahul Kapoor, Chef Ashish Basin, and many such chefs came to the NASVI food Stalls and tasted the food prepared by the street food

vendors, which was such a delightful moment for the vendors as this opportunity gave them the chance to cook and serve their delicious food to eminent personalities. Many respected government authority personalities also come to the stalls and taste the food, they also meet the street food vendors and appreciate their efforts. Such events play an important role in the advocacy for street food vendors and help in the growth of our vendors as well.

National Street Food Festival, December 2023

NASVI organised its National Street Food Festival this edition took place from the 29th to 31st December 2023 at Jawaharlal Nehru Stadium Gate number 14. The event was inaugurated by the Hon'ble Minister of Housing and Urban Affairs, Petroleum and Natural Gas, Hon'ble Shri Hardeep Singh Puri, and Celebrity chef Shri Kunal Kapoor.



Every vendor came with their special food and represented their state food at the festival, many hidden foods were also discovered at this festival and this year we have brought international cousins to the tastebuds of Delhiites. Street food vendors representing the cuisines from Turkey, Afghanistan, Nepal, Tibet, and many more participated in the festival and served the people authentic street food of their respective countries.




Besides this, it is also in full compliance with plastic base management rules where no single piece of single-use plastic has been used. All cutleries were made of natural leaves like “pattal” and wooden spoons and forks. All the organic waste was sent for composting and all the packaging plastics and paper was sent for 100% recycling. The festival stood apart from other similar events as a “Zero Waste” initiative.

Srinagar Intervention

In June 2023, 900 street vendors in Srinagar faced a forceful eviction from Batamaloo the place where they have been vending for the past 30 years to Old Bus Stand. This plan would have caused trouble to the vendors and regarding this NASVI has written a letter to the Ministry of Housing and Urban Affairs and requested to complete the redevelopment of the site or allow it in the name of the vendors at the open ground in Sector 6 if such action was to be undertaken. The action taken by was principal secretary of the Housing and Development

Department, J&K issued a letter to relocate the vendors to their original space.



Court Case

In the Legal Department, several achievements have been marked as well. The Street Vendors were evicted by the Municipal corporation of Delhi, and the Street Vendors had to face Unemployment and Struggle for Legal Aid. So, upon the intervention of NASVI and legal advice from our Advocate Mr. Ravi Nigam, NASVI supported the Vendors and fought the legal battle in the Delhi High Court, The High Court passed judgment and directed the MCD to allow these Vendors to Vend in their respective Areas. This was an important milestone achievement and decision in the favour of street vendors.

Other than such milestone decisions NASVI also intervened in many such cases where the street vendors were facing many issues. One of the instances is of Anil Kumar who has his own Tea Stall, the licensing inspector of the area was troubling Mr. Anil Kumar and was forcing him to remove his stall, despite the fact he has COV the issue continued, upon the intervention of NASVI, Anil Kumar filed a complaint against the L. I and after a few weeks, the Deputy Commissioner, MCD, transferred the Officer from that area. Another Example is Satish Kumar, who was from Karol Bagh. His goods were seized by the Licensing Inspector, upon the intervention of NASVI and legal advice from our advocate, Satish filed an R.T.I for the same, and later action was taken by the Deputy Commissioner, MCD where the Licensing Officer gave a compensation of 4,000 Rupees to Satish Kumar.

Grievance Redressal Committee

On 4th January 2023, a Grievance Redressal Committee Meeting was held in the Indian Habitat Centre which Hon’ble Minister Shri Hardeep Singh Puri, Ministry of Housing and Urban Affairs attended. On this occasion, the Hon’ble Minister mentioned how NASVI is working for the street vendors of India and the initiative of Zero Waste was one of a kind in the National Street Food Festival and **has to become a norm**. He also mentioned NASVI is working on three things that are important to the development of street vendors which are **Zero Waste, Hygiene practices, and Street Vendors skills upgradation and training**.

After the PM SVANidhi Scheme the confidence of the Street Vendors increased and as the Hon'ble Minister mentioned there is an **unprecedented wave of financial inclusivity and digital literacy**. NASVI has always worked for the betterment of street vendors and worked tirelessly to help the vendors get the benefit of the scheme.

Till now only 17 states have made the GRC and through the seminar, a message will go to many states that still have not implemented the GRC. Sanjeev Mishra's licensing & enforcement cell, MCD, Delhi also ensured that we will be working to ensure that the GRC works.



Municipal Corporation of Delhi, Survey

Three agencies have been selected to conduct the survey in Delhi, and Nidan one of them has been selected for the survey of street vendors in India. 4 zones have been allocated to us, Shahadara South, Shahadara North, Central Delhi & South Delhi. The procedure started in 2023 and an application has also been developed by the other agency. MCD is willingly delaying the survey of street vendors which is causing chaos among our vendors community. Despite paying a hefty sum to use the app for the survey, the process is as slow as the speed of a turtle. But Nidan has been pressuring the authority to conduct the survey an immediate basis.

Launch of initiative

Patna Satyagraha

After the shocking and unexpected announcement of the Divisional Commissioner of Patna Kumar Ravi said that Street Vendors will not be able to do their vending activities for almost 10 hours a day on Bailey Road, Nehru Path, Boring Road, and other places. The news came as a shock as it was affecting the livelihood of Street Vendors.

The order of the Divisional Commissioner is none less than any other order under the British Raj, it reflects the same level of atrocity, exploitation, and superiority against the *mango people*.

NASVI took immediate action on it and wrote letters to many officials regarding this decision and protested that it should be taken back, vendors should be allowed to vend and TVC meetings should be conducted.

The solidarity of Street Vendors of Patna came as an answer to the system that if exploitation is done against them, they will not hesitate to take action.

The consequence of the 3-day Satyagraha was, that Mandi was closed due to which the commodities were not sold and almost 4 crore was lost. Naturally, the prices of fruits & vegetables also went up which was the optimum sign of why Street Vendors are an integral part of our economy.

Resistance on Streets

Sarojini Nagar Case of Ms. Kanchan, Ms. Sarita, and Ms. Saroj was a prominent example of how Resilience is the key to justice. For the last 5 months, Mr. Kamal Kishore (NDMC, Enforcement Officer) has been harassing the Women Street Vendor of Sarojini Nagar.

Later, Many complaints were filed in the Vigilance Commission NDMC, DCP, Delhi Police, Vigilance Department, Delhi Women's Commission, and NHRC. After these complaints, the NASVI delegation team also had meetings with the Director of Vigilance Commission, NDMC, Mrs. Garima Singh where the NASVI Delegation team explained the issue to the officer in detail. Later, we also held a meeting with NDMC Chairperson, Mr. Amit Yadav where he was briefed about the issue and he considered the points.

After constant efforts and patience, NDMC issued a letter regarding the suspension of Mr. Kamal Kishore.


ORDER

Punjab Intervention

Street Vendors of Janakpuri were getting evicted from their place of vending. Municipal corporation authorities were evicting the street vendors from their places and authorities were seizing their goods. In the last TVC Meeting, it was notified to allocate the space in the 64 vending zone to the registered street vendors and unfortunately, that has not also been implemented. The issue was taken to the Municipal Commissioner of Ludhiana and he assured with his conversation with the zonal incharge that steps will be taken to create vending zones and street vendors will not be harassed by the authorities.

Delay in second phase of MCD survey leaves vendors vulnerable

New Delhi: The Municipal Corporation of Delhi is yet to start the second phase of its survey of street vendors even though an announcement on this had been made by mayor Shelly Oberoi in December last year. The National Association of Street Vendors of India (NASVI) has been informed that modifications to the software were the cause of the delay in the survey. Arbind Singh, executive director, NASVI, expressed concern at the lack of progress, stating, "The delay has left the vendors vulnerable and without the necessary protections and recognition that the survey aims to provide. The authorities pleaded that the software used for conducting survey was being upgraded."

Shelji also criticised a recent MCD decision declaring all street vendors as 'mobile vendors' who should not stop at a particular selling point for more than 30 minutes. He said, "The street vendors are part of society and culture but they are always being targeted by MCD. The condemnation of MCD because thousands of street vendors' lives will be affected by this step."

There was no response from the mayor's office or MCD officials on why the survey hasn't started yet.

The authorities have identified around 75,000 individuals as being street vendors. But hawkers' associations claim that there are approximately 1.5 lakh of them in the city. However, without a complete survey and identification certificates, proper management of street vendors will remain unlikely. In Sept 2020, Delhi govt notified 28 town vending committees for the first time. The first step after this notification was to conduct a survey across the entire city to identify street vendors, a process that was supposed to be completed within a month but is still ongoing.

During inspections at Laxmi Nagar and Vishwas Nagar last year as part of a cleanliness campaign, Oberoi claimed that MCD had hired three agencies and that the survey work would begin soon. She also mentioned that the problem of street vendors would be resolved in a large extent within a year or two. Now the vendor association claim that even the work begun then has come to a halt.

The city authorities face the challenge of striking a balance between the rights of the street vendors to earn a living and the concerns of traders and the public regarding their crowded presence in commercial centres and markets and their encroachment into public spaces.

NASVI Stand on MCD Decision in High Court

Intervention in the Vending zone in Varanasi under the project of Pro Paryatan by the World Bank & Ministry of Tourism

According to the Uttar Pradesh Pro-Poor Tourism Development Project Vending Zone was proposed, after the initial survey with Rishi Narayan, and the verification was done by a third party without informing us. There was manipulation and distortion in the list of street vendors

for the vending zone. The department was also trying to cover up Handicraft shops in Varanasi Sarnath which has been in the area for the longest time and has been the source of livelihood for many families. After that NASVI continuously wrote letters to concerned authorities and Rishi Narayan again was included in the committee for the allocation of street vendors to the vending zone. The result was work is being continuously done in the right manner by the authorities, vendors who were left behind are now registered and a new vending zone is also declared.

The National Association of Street Vendors of India has been associated with the street vendors of India for more than 25 years, from demanding the Street Vendors Act 2014 to implementing the act, NASVI has always been at the forefront of promoting and protecting the rights of Street Vendors of India.

According to the Uttar Pradesh Pre-Poor Tourism Development Project Vending Zone is being made in Sarnath Varanasi and some issues are being faced by the street vendors from Sarnath Varanasi and we would like to highlight them.

- The survey was conducted by the officials in collaboration with Rishi Narayan, and Chairman Sarnath Pari Paryatan Vikas, and after the survey, the verification was done through a private institution which was not authorized.
- It is proposed to distribute 286 vending carts in the Sarnath Varanasi vending zone by the World Bank and the Ministry of Tourism but during the survey and verification, the officials have tried to change the name and location of the vendors. Also, the names of some vendors are not on the list.
- There are many Street Vendors who still have not received their Certificate of Vending and License from the Municipal Corporation.
- The department is also trying to cover up Handicraft shops in Varanasi Sarnath which has been in the area for the longest time and has been the source of livelihood for many families.

We demand that action should be taken against this issue and that vending space should be allotted to authentic street vendors. We also request that the COV should be distributed to every vendor and the handicraft shops should not be displaced by the authorities. We also demand that the Street vendors who are vending in their place should not be evicted or harassed by the concerned authority.

We hope the respected authority will take positive action regarding these issues and all the taxpayers will be taken as per the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014.

TVC is the core & first step of implementing the act and therefore, immediate actions must be taken for the formation of TVC, officials taking the meetings, and implementing the act. After doing rigorous press meetings and making press releases, we managed to reconstruct the TVC committee and in the first meeting of TVC on 11/1/2024, NASVI took advantage of raising voices for vending zones through TVC members, resulting in NASVI, the Guwahati team along with TLF and ASVA went to every market to map every possible vending zone area and proposed 130 potential vending zones, and 22/2//2024 we able to get 81 free vending zones (non evicted) declared.

NASVI has also been given the responsibility to make a Vending Zone model to GMC.

Respected Sir,

The National Association of Street Vendors of India has been associated with the street vendors of India for more than 25 years, from demanding the Street Vendors Act 2014 to implementing the act, NASVI has always been at the forefront of promoting and protecting the rights of Street vendors of India.

We would like to bring your kind attention to the many issues that are being faced by the street vendors of Jodhpur on a regular basis and would request you to look upon It and take strict action on the following issues.

1. In 2016 Survey was conducted in the Jodhpur area and till now, no receipt, No Certificate, and no document has been given to the street vendors even then they have asked for it repeatedly. Over 2,500 Certificates are in the office and still not being distributed to the vendors.
2. Street Vendors have also applied for the Loan under the PM SVANidhi Scheme and for that they did not get the certificate. Even though street vendors have asked the authorities many times, still they have not received their Letter of Recommendation.
3. Since 2016 there has been no election for the Town Vending Committee and since 2020 there has not been a single meeting of TVC.
4. The Street Vendors of Jodhpur are continuously being evicted by the officers of Jodhpur Municipal Commissioner. This is clearly against the law as per Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act 2014

The mention is some of the issues Street Vendors of Jodhpur are facing and we request you to look and act upon it at the immediate hour. We want certificates of Survey & PM SVANidhi should be given to the street vendors. We also want the Re-election of the TVC should be conducted at the immediate hour and TVC meetings should be called upon at regular times and should be attended by the concerned officer. The eviction of street vendors must be stopped and allow the vendors to work in their respective areas.

We hope the respected authority will take positive action regarding these issues.

Subject- Encroachment of Street Vendors by Authorities

Selling affordable street food is not a criminal act but it's the fundamental right of street vendors in India and the authorities of Jabalpur are encroaching on the vendors from their place of vending and harassing them by seizing their goods. From the Municipal Corporation of Jabalpur to the police, the administration of Jabalpur treated the street vendors and street vendors like criminals and collected heavy fines by vandalizing the stalls with bulldozers and confiscating goods. This is their constitutional and now also statutory right. Recently, more than 50 street vendors who had been selling street vendors for more than 25 years from **Malviya Chowk in the Milliniganj** area were vandalized and removed with sticks and bulldozers, and street vendor Abhiraj Sahu and his two sons were arrested to raise their voices against this issue. A report was filed against Ankit Sahu and Aman Sahu in the Kotwali police station and they were sent to jail. There are more than **80,000 street vendors in Jabalpur city**.

The constitutional bench of five judges of the Supreme Court had given a historic decision in the Sohan Singh vs. New Delhi Municipal Corporation case [(1989) 4 SCC155] that street vending is the oldest business in India and the world and is older than other businesses. And like other businesses street vending also comes under **Article 19(1) (g)** of the Constitution and is their Fundamental right. Even in a developed country like England, a law has been made to regularize this right in 1982. But in a welfare state like India, if a law is not made, the courts will have to intervene. After this, in the case of **Gendaram vs. Delhi Municipal Corporation (2010) 10 SCC 715**, the Supreme Court directed the concerned government to make a law to regularize it. Expressing anger in the Supreme Court in the **Maharashtra Ekta Hawkers Union vs Municipal Corporation Greater Mumbai case [(2014)1 SCC490]**, he said that it is unfortunate that the police and local administration behave badly with the street vendors.

The continuous eviction of street vendors is an unfortunate action taken by our authorities and therefore we humbly request you stop these kinds of actions against the street vendors of Jabalpur and help to maintain the street food culture which is one of the highlights of our Indian Culture.

We request you have a meeting on these issues and find a solution to the encroachment and harassment for the sake of street vendors' lives and livelihoods.

Autonomous and Financially Independent Vendor Associations are being formed in three cities Patna, Bhagalpur, and Dhanbad

Following consistent follow-ups by the TLF (Town Vending Committee) in Bhagalpur, the Bhagalpur Municipal Corporation distributed 16 vending kiosks in Lajpat Park. Subsequently, with continued coordination between the market committee, TLF, and the municipal corporation, 130 vendors were allocated vending spaces in the Sendic Compound area.

In the Mayagunj vending zone, although 47 vendors were present, only 26 vending kiosks were initially allotted during Phase 1. However, due to persistent follow-ups by the market committee and TLF members, the Bhagalpur Nagar Nigam initiated the construction.

In another instance, prompted by diligent follow-up actions by TLF leaders from Patna and the NASVI (National Association of Street Vendors of India) team, street vendors were organized through lining in Rajbansi Nagar, Boring Road, Dinkar Golambar, and the Station area. Furthermore, as part of the Smart City initiative, 400 shops were established on Marine Drive, where street vendors were regulated effectively. Approximately 6000 street vendors were successfully regulated within designated vending zones during this period.

Moreover, in Dhanbad, numerous vendors found settlements in the vending zone established at Kohinoor Maidan. A total of 232 street vendors were accommodated here, providing them with employment security.

Serve Safe Food

Last year, NASVI trained more than 27 thousand street food vendors in 20 states. The training session with street food vendor aims to enhance their livelihood by improving personal and food safety hygiene. The collaborative approach creates awareness about hygiene various modules of hygiene practices that are required to serve food to customers. In this process, future street vendor leaders and street vendors are also identified. The process involves an intense on-ground mobilization process where vendors are informed about the training sessions. An important factor is vendors get a FoSTaC Certificate which is essential to have for every food vendor.



Fellowship Project

The fellowship program of the has been initiated in five major cities of India with the idea of promoting street vendors as the frontline workforce for monitoring and promoting the effective implementation of the Street Vendors Act 2014. The Fellowship Programme has been planned with a sustainable approach where vendors get equipped to take charge of intervention for the protection of the rights and entitlements of street vendors in their area.

The Fellowship project has completed its 2.5 years and slowly becoming a model program that will be further scaled up to more areas of NASVI's intervention.

Cities of Intervention:

Vijayawada (Andhra Pradesh), Bhubaneswar (Odisha), Jamshedpur (Jharkhand), Guwahati (Assam), Bangalore (Karnataka)

Major Activity

- 1- Street vendor leadership and formation of Sustainable Street Vendor organization
- Monthly Meetings in 225 Markets to raise issue and

- Formation of Market Committees in approx 150 markets.
- Bringing a consensus to form Town Level Federation in Vijayawada and steps has been initiated at Jamshedpur. In Bangalore, Bhubaneswar and Guwahati TLF are formed.

2- Advocacy for Vending Zones.

During the intervention period there have been various efforts to make the existing Vending Zones Functional and Also Declaration of Vending Zones for Surveyed and Certified Street Vendors.

As consistent follow up 81 Vending Zones have been declared in Guwahati and Bhubneshwar Municipal Corporation has started listing existing street vendors for giving them space in proposed Vending zones.

6. Facilitating Access of PM Svanidhi Loan to Street Vendors.

As given above 15500 street vendors have been supported for applying PMSVANIDHI loan. The team has organized more than 100 Market camps in the reporting period to facilitate access of the scheme. Other than the application team has also helped street vendors in post application for disbursement of loan amount.

mDiabetes

In Mumbai, NASVI is collaborating with Arogya World to conduct a mDiabetes program. Arogya's mDiabetes program involves using text messages to instruct street vendors in India on how to prevent diabetes through healthy living.

During the period of February 2024 to May 2024, we registered 7000 street vendors in this program in Mumbai. Our pioneering effort involved sending WhatsApp messages to street vendors about diabetes and its prevention.

On February 18th, 2024, a community event was organized in Mumbai to raise awareness about diabetes and its prevention. There were 52 street vendors and their leaders present, and one of the doctors guided them.

Introduction to the project

Street vendors represent a very important factor in the urban informal economy and play a vital role in ensuring the availability of goods and services at affordable rates at the doorstep of the city dwellers.

The COVID-19 pandemic and subsequent lockdowns have had a detrimental impact on the livelihoods of street vendors. These changes prompted the government to launch initiatives to assist street vendors such as PMSVANidhi. Initiated to support a particularly vulnerable population at risk due to widespread restrictions on movement, the project had a significant impact.

NASVI, with the help of the American India Foundation (AIF), is working to improve the livelihood the 52,500 street vendors of Mumbai, Surat and Morbi city.

Intervention Area is Mumbai, Surat and Morbi.

The following are the targets for the enrolment of street vendors:

Successful Achievements of the set target.

National Association of Street Vendors of India (NASVI) successfully completed this street vendors livelihood project with the support of American India Foundation. In this project period NASVI team successfully enrolled **52,992 street vendors from Mumbai, Surat and Morbi city (Maharashtra & Gujarat State)**. Among those enrolled vendors **20,679 no of vendors are female**. Out of **52,992 enrolled street vendors 43,601 street vendors connected with PMSVANIdhi scheme because of our team efforts**. and **32,318 street vendors received loan**. **52,747 street vendors trained on digital payment methods for their income enhancement and now 52,711 street vendors using digital platform while vending**. NASVI team faced some kind of challenges during this project time like eviction drive by Municipal Corporation, unawareness about PMSVANIDHI Scheme, non-willingness of bank officials & bank pendency, police actions/harassments against street vendors, insecurity about digital platform etc. hence we achieved our set goal on timeframe.

Flood Relief Yamuna floods 2023 Delhi

Delhi witnessed one of the biggest disasters of recent times. After a huge span of 40 years, it has realized that no matter how big a metropolitan city it is, natural disasters are not far away if the environment is not given its due importance. Delhi received almost 112% more rainfall than the average so far in the last monsoon season. People residing near Yamuna were evacuated to a safer place or advised not to get out of their homes in the situation. What has become evident is that haphazard urbanization and encroachment in natural drainage ecosystems have taken a big toll on people's lives, most importantly the poor or common man's lives.

Due to a lack of access to resources and their socio-economic background, people adjust to dingy and congested neighborhoods, but when disasters like the Delhi floods of 2023 come, they are the worst hit due to these conditions. Irregularly maintained sewage and drainage systems, overcrowded habitation, illegal encroachment of colonies, and no proper garbage disposal mechanism, all add to degrading the situation. NASVI, after analyzing the situation of those affected, mobilized funds to support the victims in rehabilitation. NASVI distributed dry ration kits to the most affected communities in Delhi which helped them immensely.

Victims were mapped and mobilized, and distribution camps were organized on different dates for the distribution in the following regions. A total of 8,000 kits were distributed across these regions.
